2	Regarding material delivery E P P Indian postal department service available	Indian postal department service is not acceptable; the delivery of goods has to be made to the districts and produce acknowledgements stating that the materials have been received in good condition a per the specification with seal and signature from the concerned office.
3	Penalty 0.5% per day, Please make per week.	Penalty 0.1% of the contract amount for each day of delay would be levied.
4	E.M.D. should be returned to the successful	As per the Para 10.3 of Section II of the bid

6	Packing details to be provided block wise and advice to pack block wise (in view successful distribution in time)	The successful bidder needs to pack block wise; the block wise number of items to be packed would be intimated to the successful bidder.
7	Paper sample to given or not, last date and time to be mentioned.	As per para 7.2 of Section I of the bid document the sample paper that will be used for printing of books and calendar containing charts have to be submitted to this office on or before the last day of submission of the tender. The quality of the paper to be clearly mentioned and attested by the Bidder.
8	Calendar packing specifications to be provided, box or Cone or Cylinder please clarify	The Supplier will be required to make separate package for a set of two calendars (each calendar containing 6 charts); the package should be made in 6 inch corrugated circular box-five ply; the supplier will be required to make separate package for 25 set of calendars
9	Size of 1/8th to be specified in inches or centimeters.	14 * 21 CMs
10	90% value of the payment should be against delivery.	Payment terms would be according to the tender document.
11	Mention the number of pages for Kulu Kishori book	52 pages (including cover pages)
